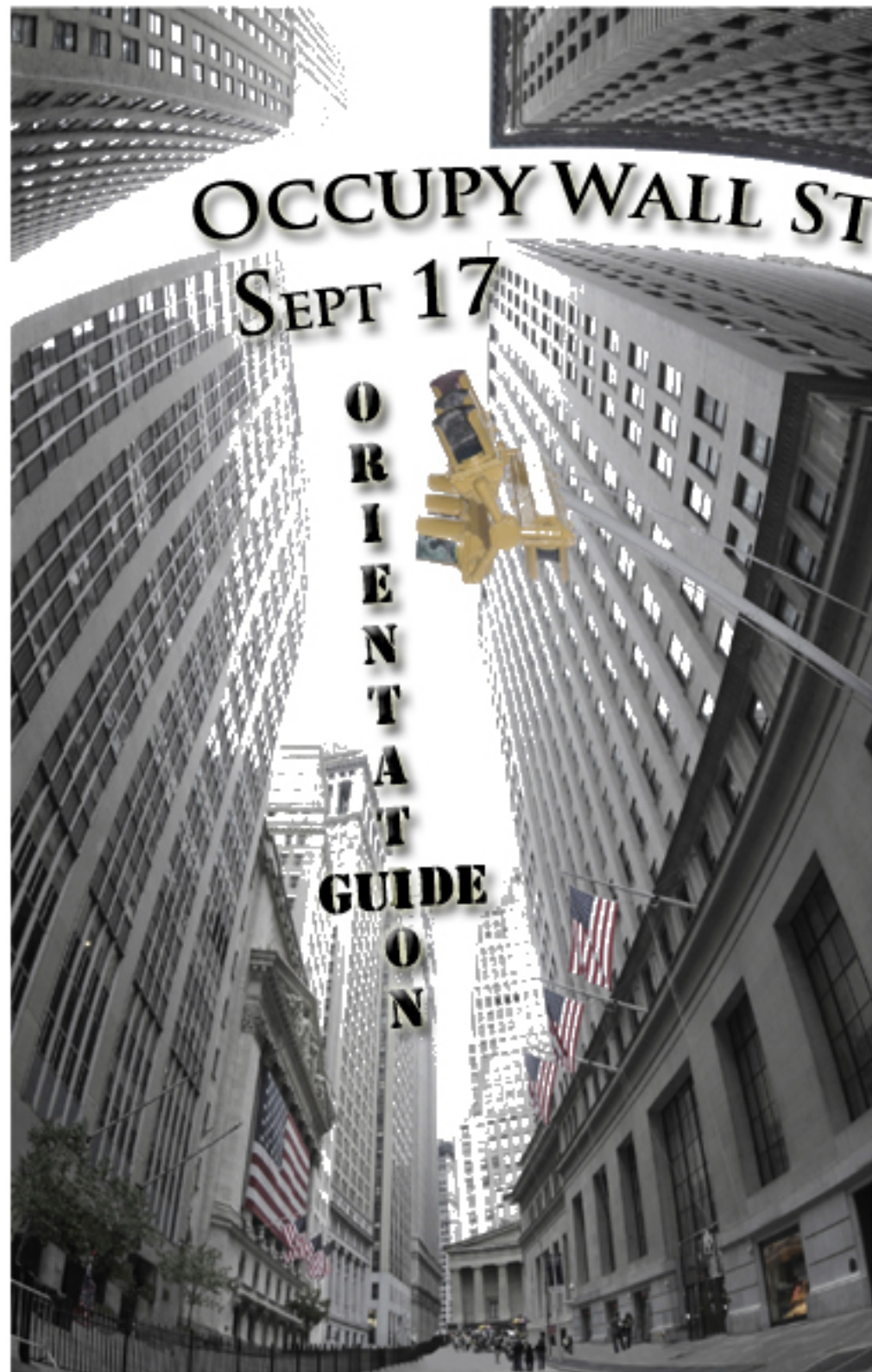

OCCUPY WALL STREET: LEGAL INFORMATION

PREPARATION

- \$ IF YOU RECEIVE A PHONE CALL FROM THE INTELLIGENCE DIVISION OF THE POLICE DEPARTMENT ASKING FOR INFORMATION ABOUT SEPTEMBER 17, YOU ARE NOT REQUIRED TO ANSWER THEM.
- \$ WRITE LEGAL CONTACTS ON YOUR WRIST OR ANKLE (NATL LAWYERS GUILD: 212-679-6018)

DURING THE OCCUPATION

- \$ YOU HAVE THE RIGHT TO RALLY ON A SIDEWALK AND SET UP A MOVING PICKET LINE SO LONG AS YOU DO NOT BLOCK BUILDING ENTRANCES OR MORE THAN HALF THE SIDEWALK.
- \$ YOU MUST HAVE A PERMIT TO MARCH IN THE STREET, RALLY IN A PARK WITH 20+ PEOPLE, HAVE A PROCESSION WITH 50 OR MORE BICYCLES, OR USE ELECTRONIC SOUND AMPLIFICATION.
- \$ IT IS UNLAWFUL FOR MORE THAN TWO PEOPLE TO WEAR MASKS OR BANDANNAS.
- \$ PUBLIC PARKS CLOSE AT 10 PM.
- \$ THE NYPD WILL TAKE AWAY ANY SIGNS THAT USE WOODEN STICKS, METAL, OR PVC PIPES, AS WELL AS ANY SIGNS THAT ARE AFFIXED TO PUBLIC PROPERTY.
- \$ HANGING A BANNER FROM A BRIDGE CAN LEAD TO BEING CHARGED WITH RECKLESS ENDANGERMENT.

IF YOU COME INTO CONTACT WITH THE POLICE

- \$ IF POLICE STOP YOU ON THE STREET, ASK "AM I FREE TO GO?" IF YES, YOU MAY SAY NOTHING AND WALK AWAY. IF NO, YOU SHOULD SAY, "I WISH TO REMAIN SILENT. I WANT TO TALK TO A LAWYER."
- \$ IF YOU ARE DETAINED AND THE POLICE ASK TO SEARCH YOU OR BAG, YOU SHOULD SAY, "I DO NOT CONSENT TO A SEARCH," AND REPEAT IF THEY CONTINUE.
- \$ IT IS LEGAL FOR THE POLICE TO LIE TO YOU TO GET YOU TO TALK OR INCRIMINATE YOURSELF.
- \$ IF YOU ARE MISTREATED, OBTAIN OFFICER'S NAME AND BADGE NUMBER AS WELL AS CONTACT INFORMATION OF WITNESSES. YOU HAVE THE RIGHT TO ASK FOR THIS INFORMATION.
- \$ IF YOU ARE INJURED, TAKE PHOTOGRAPHS OF THE INJURIES AS SOON AS POSSIBLE.
- \$ "IF YOU ARE UNDOCUMENTED, OUT OF STATUS, A LEGAL PERMANENT RESIDENT (GREEN CARD HOLDER), OR A CITIZEN, YOU DO NOT HAVE TO ANSWER ANY QUESTIONS ABOUT YOUR IMMIGRATION HISTORY [TO GOVERNMENT OFFICERS]." (NATIONAL LAWYERS GUILD)
- \$ NATIONAL LAWYERS GUILD (NLG) LEGAL OBSERVERS WILL BE PRESENT TO DOCUMENT ANY ARRESTS OR UNLAWFUL POLICE ACTIVITY. LOOK FOR THE GREEN HATS AND LET THEM KNOW IF YOU SEE ANYTHING.
